Thirty Day Notice

By executing this contract, I hereby certify that I understand and accept the responsibility of registering my child at Dynamic Movements. If I decide to no longer attend classes at Dynamic Movements, I understand that a notification must be given to the owner, either written in e-mail or verbally 30 days prior to my last class. I further agree to pay all fees and tuition due within 30 days of my notification.

Monthly Tuition

I understand that monthly tuition is due by the tenth day of each month. I also agree to pay a \$10.00 late fee with my tuition if I pay after the tenth day of the month. In addition, if tuition and late fees are not paid by the twentieth of the month, the student will not be permitted to take class for the remainder of the month. Tuition is based on four lessons a month. Students are given the opportunity to make up classes in other regular scheduled classes during months including holidays resulting in less than four lessons a month. Dynamic Movements will close for the following holidays: Labor Day, Halloween, Thanksgiving, Christmas, New Years, Spring Break and Memorial Day week end. Neither discounts nor refunds will be given for missed classes. Students who miss class due to illness or injury may also make up classes in other regularly scheduled class. Students registering in the middle of the month may also make up classes. Dynamic Movements does not pro-rate tuition rates.

June Recital

I understand that the \$100.00 recital fee is non-refundable and the recital fee must be paid at the time of registration. I also understand that recital costumes are non-refundable after November 15th. Students may still pick up costumes, but may not receive a refund.

Attendance Policy

To be fair to all students and instructors, Dynamic Movements implements an attendance policy January-June. Students may only miss 5 classes from January 1st through the scheduled recital date. If students miss 5 classes from January-June, the student will not be allowed to participate in the class recital routine. No refunds for recital fee of costumes will be given.

A class may be cancelled at any time if the enrollment of the class falls below 6 students.

To insure the safety of my child, I understand it is my responsibility to be present when my child's class ends. I also agree to instruct my child to stay in the waiting room of Dynamic Movements until either the parent or someone known by the studio picks up my child. Dynamic Movements can not be responsible for the safety of students who leave the building after classes. Written permission must be given to the staff of Dynamic Movements if your child is allowed to leave the premises for any reason. Please list the persons, other than yourself, allowed to pick up your student.
